On the basis of the above Report, it is hereby declared that all the resolutions as stated in the Notice of the 8th AGM have been duly passed with the requisite majority as per the following details:



Sub: Scrutinizer's Report on voting by electronic means conducted pursuant to provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2015 and physical ballot forms

I, Shailesh Kachalia, Practising Company Secretary, was appointed as Scrutinizer by the Board of Directors of West Leisure Resorts Ltd("the Company") vide its decision dated 25thJuly, 2014, pursuant to Section 108 of the Act, read with the Rules made thereunder, to conduct the electronic voting process and to scrutinize the physical ballot forms submitted by shareholders of the Company, in respect of the below mentioned resolutions to be considered for passing at the Eighth Annual General Meeting ("AGM") of the Company on 30th September, 2016.

The Notice dated 8thAugust,2016 convening the said AGM of the Company was reportedly sent to the shareholders in respect of the said mentioned resolutions.

The Company has availed the remote e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting remote e-voting by shareholders of the Company. The Company has also provided facility of voting by physical ballot papers, at the AGM, to its members who do not have access to remote e-voting facility including those who became members of the Company after dispatch of the aforesaid notice till the cut-off date of 23.9.2016.

The voting period for remote e-voting commenced on Tuesday, 27thSeptember 2016 at 9.00 a.m. and ended on Thursday, 29thSeptember 2016, at 5.00 p.m. The NSDL remote e-voting platform was thereafter blocked. The votes cast under the remote e-voting facility were then unblocked in the presence of two witnesses, not in the employment of the Company. No votes were cast through ballot forms at the meeting.

Based on the data downloaded from the NSDL remote e-voting system, I have scrutinized and reviewed the voting.

I now hereby submit my Report as under on the result of the voting through electronic means and the physical ballots in respect of the said Resolutions as under.


